# **ALLOCATION OF ANTI-DOPING COSTS FOR IWF SANCTIONED EVENTS<sup>1</sup>**

**BETWEEN 1 MARCH 2019 – END OF TOKYO 2020  
QUALIFICATION PERIOD**

Due to the fact that the IWF has delegated the management of the IWF's Anti-Doping Programme to the International Testing Agency (ITA), for sample collections conducted during IWF Events under these Guidelines/this Regulation ITA is solely entitled to appoint the responsible Sample Collection Authority and Laboratory in accordance with the provisions of the IWF Anti-Doping Rules. The International Testing Agency is also solely entitled to determine the number of Doping Control Officers, Chaperones and any other Sample Collection Personnel required for the IWF Event in question.

Any costs incurred in relation with Anti-Doping activity conducted at IWF Events that are not listed in these Guidelines/this Policy shall be borne by the IWF unless other IWF Rules or Regulations stipulate differently or the Organising Committee and the IWF agree otherwise.

## **1) TOKYO 2020 QUALIFICATION EVENTS:**

### **a) GOLD:**

#### **i) IWF World Championships, IWF Junior World Championships**

##### **(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of six (6) Doping Control Officers;
- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;

##### **(2) Participants of the Event shall be responsible to cover the Entry Fee and a 50 USD/Athlete special Anti-Doping fee:**

- (a) 50% of the entry fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

<sup>1</sup> For the avoidance of doubt IWF Sanctioned Events are the IWF Events listed under Article 5 of the IWF Technical and Competition Rules & Regulations with the exception of the Olympic Games, the Youth Olympic Games, other Multisport Games, the World University Championships and the Universiade.

- (b) The 50 USD/Athlete special Anti-Doping fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

**(3) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;
- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.

**ii) Continental Championships and Junior Continental Championships**

**(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of four (4) Doping Control Officers;
- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;

**(2) Participants of the Event shall be responsible to cover a 50 USD/Athlete special Anti-Doping Fee:**

- (a) The 50 USD/Athlete special Anti-Doping fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

**(3) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;
- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.

**b) SILVER**

**IWF Grand Prix, other International Competitions**

**(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of four (4) Doping Control Officers;

- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;

**(2) Participants of the Event shall be responsible to cover a 30 USD/Athlete special Anti-Doping Fee:**

- (a) The 30 USD/Athlete special Anti-Doping fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

**(3) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;
- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.

**c) BRONZE**

**International Championships, Cups, etc.**

**(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of four (4) Doping Control Officers;
- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;

**(2) of the Event shall be responsible to cover a 20 USD/Athlete special Anti-Doping Fee:**

- (a) The 20 USD/Athlete special Anti-Doping fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

**(3) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;
- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.

## **2) NON-QUALIFYING IWF EVENTS<sup>2</sup>:**

### **a) IWF Youth World Championships:**

#### **(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of six (6) Doping Control Officers;
- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;

#### **(2) Participants of the Event shall be responsible to cover the Entry Fee:**

- (a) 50% of the entry fees collected at the Events shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

#### **(3) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;
- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.

### **b) Other IWF Events:**

#### **(1) The Organising Committee of the Event shall be responsible to cover:**

- (a) The costs of travel, accommodation, full board and local transportation of a maximum of four (4) Doping Control Officers;
- (b) The costs of the transportation of the urine and blood samples to the Laboratory selected by the International Testing Agency;
- (c) A fee of 100 USD/Doping Control Officer/Competition day shall be paid by the Organising Committee to the IWF and shall be used for Anti-Doping purposes.

#### **(2) The IWF shall be responsible to cover:**

- (a) The costs of sample analysis incurred in connection with samples collected under the IWF's authority during the Event;
- (b) The costs of sample collection equipment incurred in connection with the sample collection conducted under the IWF's authority during the Event;

- (c) Any further costs incurred in connection with sample collection conducted under the IWF's authority during the Event.
